



Completed purchases under long-term retention plan

(Trondheim, 4 August 2026) OKEA ASA (OSE: OKEA) completed share purchases 3 August, in connection with the long-term retention plan (LTRP).

The share purchases on behalf of leading employees were made in accordance with the company's LTRP. The shares are subject to a 24-month lock-up period.

The purchases were executed by Pareto Securities AS on behalf of leading employees at OKEA, all primary insiders. A total of 55 330 shares were purchased at an average price of NOK 33.8872.
